**'Build a stronger and sustainable domestic game'**

**Joined-up approach with the Welsh Ground Improvements (WGI)**

**Mandatory for the 2018 / 19 season**

**Huws Gray Alliance 13**

**Welsh League 1 14**

**Tier 3 14**

**Bangor City & Prestatyn Town**

**Tier 2 Certification last for one season – Annual Process**

**Applications must be received by 31<sup>st</sup> December each year, via the FAW CSN Portal**

<b>31st December 2018</b>	<b>Submission deadline for Tier 2 Certification Application</b>
<b>January / February 2019</b>	<b>Ground inspections take place (if required)</b>
<b>30th April 2019</b>	<b>Deadline for submission of all documents and ground developments</b>
<b>9th May 2019</b>	<b>Tier 2 First Instance Body meets in Cardiff</b>
<b>23rd May 2019</b>	<b>Tier 2 Appeals Body meets in Cardiff</b>

#### General Manager

Responsible for the day to day running of the club

#### Finance Officer (Treasurer)

Chartered Accountant / Qualified Auditor / 'Recognition of Competence'

#### Media Officer & Output

Diploma in journalism / FAW Media Course / Recognition of Competence

Official Website / Social Media Accounts

#### Emergency Aid Officer

First Aid for Sport & Exercise 1 (FASE 1) / Attends all Matches

#### First Team Manager

UEFA B Licence Qualification / Must attend at least 70% of matches

#### Safeguarding Officer

Valid DBS / FAW Safeguarding Award / Safeguarding Policy

#### Stewarding

Safety & Security / Safety Policy

### *Legal*

#### Minimum Legal Information

Current, valid statutes / FAW Full Membership Form

#### Security of Tenure of Stadium

Stadium Availability during the licence season / Meet Tier 2 Ground Criteria

**16 Tier 1 Licensed Clubs 2018 /19 season (6 from Tier 2)**

### Financial Incentives for Promoted Clubs

**FAW Pyramid Review - £10,000 to cover operational costs**

**Up to £25,000 for TV Gantry Facilities**

**Up to £50,000 for Infrastructure Upgrades**

### Timeline 2018 / 19 – ‘ Core Process’

**23rd August 2018**

**FAW to invite clubs to apply for the UEFA and Tier 1 Licence (£350)**

**10th September 2018**

**Submission deadline for UEFA and Tier 1 Licensing applications**

**10th September 2018**

**Template documents available on USB if requested**

**Nov/ Dec 2018**

**Site visits for Stadium Audits & updated Action Plans sent**

**31st March 2019**

**Deadline for submission of all documents**

**4th April 2019**

**First Instance Body meets in Cardiff**

# FAW Tier 1 Club Licensing Regulations.

## *Key criteria*

### Sporting

Youth Development Programme (U12, U14, U16, U19)

Player Medicals\*

### Stadium Infrastructure

All criteria does not have to be met to attain Tier 1 Licence (£50k for promoted club)

### Personnel

In addition to Tier 2 requirements – First Aid Officer (STM 1), First Team Manager (A Licence), Head of Youth (A Licence), Youth Coaches Qualifications (A, B x 2, rest = C), Assistant Manager (A Licence)

### Finance

Annual Audited Financial Statements\*
